Subject: Proposed Changes to the Chapter Bylaws

The Chapter President asked the Bylaw Committee review the Bylaws and present changes for the Board to review. The Bylaw Committee consisting of Chair: Frank Donovan, Phil Clark, Don LaBrenz, George Little and David Williams, have met a few times over the past year and presented to the Board at their December Board Meeting a proposed set of Bylaws. The Committee upon recommendation of the Board of Directors and the IAEI office made a few changes and then presented a proposed set of Bylaws for a vote by the Inspector members of the Board of Directors for their vote. A unanimous vote to approve the proposed 2012 set of Bylaws was complete on December 14, 2011. In order for the Bylaws to move forward, an approval vote of 2/3rds of the Inspector Members of the Chapter is required.

Attached in this mailing are the proposed 2012 Proposed Bylaws, and a postage paid Post Card Ballot. The Ballot needs to be sent within 20 days after receiving the ballot. The Proposed Bylaws contain minor changes as well as a few major changes from the previous version. The following are some of the proposed major changes.

- To have the ability to keep the positions of Secretary and Treasurer separate or to combine the duties.
- To have the President of the Chapter to Chair the Board of Director meetings and to select all of the Committee assignments.
- To delete the position of Chair of the Board of Directors since the Chapter President will be filling those duties.
- To allow the immediate past president to stay on the board of directors at his/her option.
- To add a section for the removal from office for misconduct or other good cause.
- To allow a Senior Associate Member to vote on candidates for office.
- To allow the Board to vote on matters using electronic balloting.
- To establish a new standing Budget Committee.
